

Who We Are

One of six regional health information exchanges in New York State, serving the 8 counties of Western New York (WNY) (Erie, Niagara, Cattaraugus, Chautauqua, Alleghany, Wyoming, Orleans, and Genesee).

Founded in 2006 via collaboration and funding from the region's major hospital systems and health plans including Catholic Health System, Erie County Medical Center, Highmark Blue Cross Blue Shield of Western New York, Independent Health, Kaleida Health, Roswell Park Comprehensive Cancer Center, and Univera Healthcare.

A central hub of regional clinical data accessible via patient consent by community providers to improve patient care. HEALTHeLINK enjoys high participation within the region it serves. The more than 500 data sources include:

- ❖ 100% of regional hospitals
- ❖ 70% of physician practices, representing approximately 5,000 providers
- ❖ 90% of the radiology studies performed
- ❖ 95+% of lab results

Approximately 85% of the WNY community is consented for access of their records

What We Do

Provide core HIE services:

- ❖ Individual patient record lookup
- ❖ Deliver Admission/Discharge/Transfer (ADT) alerts to providers for their current patients
- ❖ Results Delivery to the EHR

Provide HEDIS data to local health plans as an NCQA Certified Data Validator:

- ❖ Rigorous certification process HEALTHeLINK participates in annually
- ❖ Intense focus on data quality policies and procedures and ensuring that incoming data aligns with data within a data source's EHR

Provide population health, public health, and research reporting:

- ❖ A robust population health data warehouse that combines clinical data from community data contributors and claims data from regional managed care organizations
- ❖ Data is staged to pull key clinical quality metrics, risk scoring, SDOH data, hospital/ED utilization on a specific population within the 8 counties of WNY using demographic, clinical, or treating relationship criteria
